### **Aim of the study visit :**

The aim of the study visit is to share knowledge and good practice with the Administrative Tribunal of Tunisia about the decentralisation process of the administrative justice system in Croatia. Tunisia is in the process of decentralising the administrative courts of first instance and administrative courts of appeal with a view of facilitating access to justice in all the municipalities.

Participants will be introduced to the organisation and functioning of the Croatian judicial system, with particular emphasis on the Civil, Commercial and Administrative Law Directorate. The reform of the administrative justice system in Croatia will be analysed and discussed with representatives from the Ministry of Justice, the High Administrative Court and the Administrative Court in the city of Osijek.
